## LANDSCAPING

No freezes yet, but you might keep in mind that during and after freezing weather a couple things should be remembered.

- 1) Do not trim/clean/trash any plant that might look dead. Just because the foliage is dead, it does not mean the plant is dead. Wait until spring to see if plant has any new foliage.
- 2) Give your plants a good soak down before freezing weather. This will insulate the root ball and keep them alive. Cover any tropical/fruit trees and annuals.
- 3) Make mounds around plants with tree leaves to insulate plants.
- 4) Cover plants with fabric/weed barrier material to insulate plants.

We want to take this opportunity, again, to thank Bill Cox and LMC for their consistent care for the OSB esplanades at the Wirt Rd/Hammerly and the Antoine/Long Point entrances. OSB appreciates your many years of support and help.



## CITIZENS ON PATROL – HOUSE NUMBERS, PROTECTING YOUR HOME

Christmas is over and 2024 has begun. Wishing all a very Happy New Year!

### Resident House Number Display

I am very excited about our 'Resident House Number Display' event. I cannot even tell you how important it is to have your house numbers displayed properly; especially, if you need immediate emergency assistance from our police or fire departments. I have noticed that while patrolling during the day how some house numbers are hardly visible and at night, they are not visible at all. I hope we can get everyone to take a second look at their house numbers.

### Protecting your home from criminals

Here are a few tips to discourage criminals from targeting your house:

- Install lights in areas around doors, walkways and driveways.
- Locate outside lights high and out of reach.
- Use inexpensive timers and photo electric cells to automatically turn the lights on and off at dusk and dawn.
- Trim shrubbery and trees so doors and windows are visible from the street.

- Do not leave ladders or tools outside, they can assist a person in gaining entry.
- Gates on fenced yards should be locked with good quality padlocks.
- Install large numbers (minimum 3 inches) on your house so police and other emergency personnel can find your home quickly.

As always, be aware of your surroundings! Stay alert, be diligent and report any incidents that you see or hear. If the Police department is not aware of anything going on in our neighborhood, they will not patrol our area. You can call the non-emergency number at 713-884-3131. If it is life-threatening situation, please call 911!

We will post our December Citizens on Patrol (CP) hours in February's newsletter due to the Bugler's deadline. As always, I want to thank our CP volunteers for patrolling our area whenever possible. ## RESIDENT HOUSE NUMBER – OSB DRAWING

I have been approved by the OSBCA Board of Directors to present to you, the residents, two (2) \$100 drawings of \$100 each for following one of the City of Houston's codes: Resident House Numbers.

RESIDENT HOUSE NUMBER entry into an OSB drawing to win \$\$\$ two drawings of \$100 each. Every single-family resident of OSB is eligible. (No businesses nor multi-family projects). The OBJECTIVE OF THIS "ENTRY TO WIN", is to encourage ALL residential properties to have its House Numbers posted as required by the City of Houston Code.

"Code violations" Fines & Compliance. Neighborhood Protection, City of Houston "quote" MISSING ADDRESS NUMBERS. "The owner/occupant is responsible for displaying and maintaining numbers that identify the property at all times. Fine: \$100-\$150. To Avoid fines: Permanently affix the address assigned to the 18" of the building's entrance. The numbers must at least 3" tall and of a contrasting color"

RULES OF THE OSB DRAWING: (We, OSBCA may have modified the Ordinance somewhat).

1. Numbers must be at least 3" tall.
2. Numbers must be in contrasting color.
3. Numbers must be posted to be seen from the street (day or night).
4. Numbers may/can be posted on front (fascia of house), carport, or garage.
5. Painted curb numbers are NOT eligible.
6. Board Members are NOT eligible for drawing, but must be in code compliance.
7. Properties in Deed Restriction violation do NOT qualify until property is in compliance.
8. Any objects obstructing the address numbers should be removed so address numbers can be seen from the street.
9. Drawings will be made in April 2024. Winners will be contacted in April.

Every Resident House Number that meets all the criteria (1-9) has been and is being entered in the drawing. The Board of Directors will continue to drive through the neighborhood, writing your eligible number down on an entry blank and depositing it in a draw container. We will print out a street numbers that have been entered and put in the Bugler every month until the drawing. Winners will be announced in the May Bugler hard copy. I hope to see that all residents will meet the challenge. Good luck!

- **Cartons:** Both gable top and shelf-stable food and beverage cartons. Examples include milk cartons, juice cartons, soup cartons, soy milk/alternative milk cartons (emptied and rinsed)
- **Glass:** Bottles, jugs and jars only (emptied and rinsed)
- **Paper:** Newspaper, magazines, catalogs, junk mail, office paper
- **Cardboard:** Cardboard and cereal boxes (emptied of packing materials and flattened)
- **Plastic:** Bottles, tubs and jugs #1 - 5 and 7. Examples include water and soda bottles, milk jugs, yogurt cups, margarine tubs, detergent bottles, shampoo bottles. (emptied and rinsed)
