THE IMPORTANCE OF CLEARLY MARKED HOUSE NUMBERS IN AN EMERGENCY FOR PUBLIC SAFETY

“Time is critical for first responders. Even with the use of GPS and turn-by-turn directions, locating a home quickly and easily in an emergency can save lives. **If firefighters cannot see your house numbers, it will slow them down.** Fire departments urge you to look at your house numbers and if you can’t see them from the street, DO SOMETHING about it before an emergency. **BE SURE YOUR HOUSE NUMBERS ARE EASILY VISIBLE TO FIRST RESPONDERS!”**

The above article is another **important reason** that Old Spring Branch Civic Association decided to do a “two (2) \$100 drawing” for residents that live in the OSB area. In addition to this, it is a City of Houston Ordinance/Code that is required for each and every citizen in the City of Houston. The “drawing” that the OSB Board of Directors has launched is an encouragement to get our residents in compliance with the law and into a “more safe” environment.

Members of the OSBCA Board of Directors have and are taking the time to enter each of the residents that ARE ALREADY in compliance in the “Drawing”. **We have observed the following reasons that some of you cannot be entered in the “drawing”:** 1) Numbers on plaques are too small to see 2) Missing one or two numbers or no numbers posted 3) Numbers cannot be seen at night (porch lights should be lit every night for safety) 4) Shrubs and/or tree limbs blocking view of house numbers on house 5) House numbers on curbs, not on house. (The City of Houston Ordinance requires that the numbers be 3” tall, be of contrasting color, and posted on front of house).

By the end of April, we, the Board of Directors will check the neighborhood residences to see if, “out of compliance” house numbers residences have gotten into compliance. Then, those residents will be put into the “drawing”.

The two (2) “drawings” will be the last week of April and the winners notified by the OSBCA Board of Directors.

RESIDENT HOUSE NUMBER – OSB “ENTRY TO WIN” DRAWING

TWO (2) \$100 DRAWINGS to be held in April 2024.

RULES OF THE OSB DRAWING: (We, OSBCA may have modified the Ordinance somewhat).

1. Numbers must be at least 3” tall.
2. Numbers must be in contrasting color.
3. Numbers must be posted to be seen from the street (day or night).
4. Numbers may/can be posted on front (fascia of house), carport, or garage.
5. Painted curb numbers are NOT eligible.
6. Board Members are NOT eligible for drawing but must be in code compliance.
7. Properties in Deed Restriction violation do NOT qualify until property is in compliance.
8. Any objects obstructing the address numbers should be removed so address numbers can be seen from the street.
9. Drawings will be made in April 2024. Winners will be contacted in April.

Every resident house number that meets the Criteria (1-9) has been and is being entered in the drawing.



GARAGE/YARD SALES - ONLY TWO (2) A YEAR

Below is useful information to provide those abusing yard and garage sales in our neighborhood.

Ordinance highlight regarding Texas Tax Code

As we begin the spring/summer months, garage/yard sales will become a focus. We would like to remind residents of the rules and regulations behind these kind of sales. Garage/yard sales are not regulated by the City of Houston. The Office of the State Comptroller regulates these types of sales. **RESIDENTS ARE ALLOWED TO HAVE ONLY TWO (2) SUCH SALES WITHIN A TWELVE (12) MONTH PERIOD.** Any more than two, the resident is recognized as having a business and must obtain a **tax permit from the State**. Since many subdivisions prohibit solicitation and commercial businesses within residential areas of a neighborhood, such activity is restricted.

For residents who try to operate a business in their homes, there are other city requirements that must be met. Specifically, at a minimum, the resident must obtain a Certificate of Occupancy. **There is NO PERMIT known as a "Garage sale permit."** The Texas Tax Code, Title 2, Chapter 151, Section 304 underlines the use of sales tax in occasional sales (too much information for most folks that have only two garage/yard sales a year).

I have checked mine and I fall into this category so I will be checking into some solar lighting or additional landscape lighting to see if that helps. It acts as a spotlight on the front door, you can easily see who's approaching through either a window or peephole. It's also nice if you have kids staying out after dark or guests coming to visit and/or food being delivered.

There were only 13 trash cans left out on the street this week. - **Metal and Cans:** Aluminum and Tin Cans. Examples include soup cans, vegetable cans, fruit cans, coffee cans (emptied and rinsed)
- **Cartons:** Both gable top and shelf-stable food and beverage cartons. Examples include milk cartons, juice cartons, soup cartons, soy milk/alternative milk cartons (emptied and rinsed)
- **Glass:** Bottles, jugs and jars only (emptied and rinsed)
- **Paper:** Newspaper, magazines, catalogs, junk mail, office paper
- **Cardboard:** Cardboard and cereal boxes (emptied of packing materials and flattened)
- **Plastic:** Bottles, tubs and jugs #1 - 5 and 7. Examples include water and soda bottles, milk jugs, yogurt cups, margarine tubs, detergent bottles, shampoo bottles. (emptied and rinsed)

BUILDING PERMITS – CITY OF HOUSTON & DEED RESTRICTIONS

IMPORTANT! Building permits must be in compliance with Deed Restrictions!

To protect the neighborhood character and property values, the City of Houston is cooperating with citizens to ensure building permits **are not issued** in violation of deed restrictions.

Before you begin new construction or home improvement project, please consult your civic association regarding possible deed restrictions. You may not purchase a building permit without signing a sworn deed restriction affidavit stating that you are aware of and agree to abide by deed restrictions pertaining to your project.

The building permit application needs to have the correct legal description, including the subdivision name and the Deed Restrictions Affidavit on the back of the Permit, must be filled out. (a legal description can be found on the title to your property) Customer Service Representatives will check the subdivision listed on your permit application against a database index of restrictions. All construction projects **MUST** be in compliance with a community's deed restrictions. If you knowingly, or unknowingly, sign the deed restriction affidavit under false pretenses, you could be subject to municipal court citations, fines, and the removal of the structure or violating portion thereof.

To research restrictions, you can:








- Check to see a Notice of Restrictions was provided at closing (required by title insurance in recent years).
- Obtain a copy of the restrictions from either Harris County Clerk's office (713-755-6411), or through the appropriate homeowners association or civic club.
- Contact a title abstract company to obtain a copy of the restrictions or a letter stating that there are no restrictions.

Projects that require a permit include:

- New construction of building or structures
- Alterations, repairs or additions to existing buildings or structures.
- Changes in the use or occupancy of an existing building or structure.
- Interior tenant lease build-outs, remodeling and repairs.
- Exterior remodels, alterations or repairs.
- Moving/relocation existing buildings.
- Demolition (interior and complete buildings).
- Fences over 8' high.
- Driveways and sidewalks (in city R.O.W.)
- Parking lot paving
