It is so important, too, that porch lights be kept on during the night to illuminate one's house numbers, and so any unwanted persons can be easily spotted on and around your home.

A reminder, **the month of May is our OSBCA Membership Drive.** Membership applications will be in the Bugler and an OSBCA addressed envelope will be attached to the front of your "Hard Copy" Bugler. TWO \$100 HOUSE NUMBER DRAWINGS HAPPENING AT THE END OF APRIL

The “House Number Drawing” will be in the last week of April 2024. There is still time to check your house number to see that it got written down and put into the “House Number Bag”. **That “bag” is a 13 gallon kitchen trash bag that contains all House Numbers that are 3” high, in contrasting color, are posted/visible on the front of house and/or garage, car port.**

House numbers that are NOT eligible are: Residences that are in Deed Restriction Violation, City of Houston Code Violation, have address on curb, missing a number, too small numbers on plaques, and numbers that cannot be seen from the street. **Additional ineligible house numbers are:** OSBCA board members, businesses, multi living facilities, new townhouse developments that do not have an OSB street address.

Two one hundred dollars (\$100) prizes will be given to two (2) residents whose eligible house numbers are drawn. **The winning house numbers will appear in the May (hard copy) Bugler. The winners will be able to pick up their prizes at the OSBCA Quarterly Meeting, Tuesday, June 11, 2024, 7 p.m., Trini Mendenhall Civic Center, 1414 Wirt Rd.**

OSBCA board members will be driving through the neighborhood, checking for possible ineligible house numbers that have become eligible, April 27-30.

It is STILL time to get into compliance to be placed in the house drawing bag. Who will do the drawing? The 6-year-old granddaughter of a board member.

Watch for the **winning addresses** in the May Bugler (hard copy) that will be delivered to residents in OSB.

RESIDENT HOUSE NUMBER – OSB “ENTRY TO WIN” DRAWING

TWO (2) \$100 DRAWINGS to be held in April 2024.

RULES OF THE OSB DRAWING: (We, OSBCA may have modified the Ordinance somewhat).

1. Numbers must be at least 3” tall.
2. Numbers must be in contrasting color.
3. Numbers must be posted to be seen from the street (day or night).
4. Numbers may/can be posted on front (fascia of house), carport, or garage.
5. Painted curb numbers are NOT eligible.
6. Board Members are NOT eligible for drawing but must be in code compliance.
7. Properties in Deed Restriction violation do NOT qualify until property is in compliance.
8. Any objects obstructing the address numbers should be removed so address numbers can be seen from the street.
9. Drawings will be made in April 2024. Winners will be contacted in May.

Every resident house number that meets the Criteria (1-9) has been and is being entered in the drawing.


MEMBERSHIP UPDATE

YARDS OF THE MONTH

It is time to begin grooming your April yards to be listed in the May 2024 Bugler. The “Yard Hawk” will ride through the neighborhood the last week of April making a note of the yards eligible for the Bugler “Yards of the Month”. Below is OSB's guide for getting your yard placed on the **Yards of the Month** list. Save this for your future use.

Criteria for Yards of the Month:

1. **Be well-groomed** (i.e. yard mowed, sidewalks edged, shrubs/trees pruned, flower beds weed-free, no dead plants)
2. **Be attractive, neat and pleasing to the eye** (i.e. green lawn, variety of plants/flowers, color contrast in landscaping, walkway/driveway/curb clean, no out-of-season decor)
3. **Have buildings, fences, porches and patios in good condition** (i.e. minimal distraction from the landscape due to deterioration, damage/construction)
4. **Be free of litter, junk and debris** (no appliances or indoor furniture on porches or patios; free of junked or inoperable vehicles; no parking on the lawn)
5. **Observe all City of Houston Codes and OSB Deed Restrictions**

CITIZENS ON PATROL – MARCH 2024

We reported a total of **35.25 patrol hours for February** and **28.50 for March**. As always, I want to thank our CP volunteers for patrolling our area whenever possible. I do believe we make a difference. We are always looking for volunteers to join our CP group. If you are interested, feel free to contact Virginia at 832-748-8088, please leave a message. My thoughts while patrolling our neighborhood in February: Construction is continuing, traffic is increasing, wondering what is going to happen to Treasure Forest Elementary next year, when is The Lively (new big, big apartment complex on Antoine) going to start leasing apartments (?), how will that increased traffic affect the 'round-about' scheduled for 2025, what does the man on Harland do to get all those flowers to grow (they are quite beautiful!), where do the men congregating at Woodvine/Long Point go to the bathroom and how many grocery carts of empty beer cans do they fill up in a day (HPD is continuing to work on this problem), why does the gated community on Jacquelyn keep their city trash cans on the street (average for last month was 15 cans) and what's going on with our City services, the 'ditch' between Woodvine and Thonig has been mowed, they are working on the street ditches on Thonig and our recycling trash cans are being picked up on their actual scheduled date! YAY!

As always, be aware of your surroundings! Stay alert, be diligent and report any incidents that you see or hear. If the Police department is not aware of anything going on in our neighborhood, they will not patrol our area. You can call the non-emergency number at 713-884-3131. If it is life-threatening situation, please call 911!

LANDSCAPING

The time has finally come to the final, safe cut back of dead plants, etc. Pull out the dead plants. Replant if you so desire. Fertilize and mulch. In addition, the grass is growing, even the weeds. Mow them down! A weed killer can be sprayed to help combat the weeds. Good Luck! 😊

Yards should be mowed at least 3" high, mulch, not caught. Treat your yard for bugs now and later in the summer. Hopefully, we will continue to get enough rain not to have to water. Do remember that Houston is still on a watering schedule: **even numbered homes on Sunday and Thursday, odd numbered homes on Saturday and Wednesday, all other customers on Tuesday and Fridays.**

Loretta Nalley, our OSB Vice President and Murphy Critelli, Steet Rep, committee of two, are working on and with Trees for Houston to replace the trees that were lost on Hammerly. In addition, replanting the Hammerly/Wirt Rd. esplanade is on OSBCA's agenda. Nino Roman, our OSB landscaper, will be planting flax lilies and revamping the drip system within a couple of weeks. The Civic Association will purchase the flax lilies.

Speaking of landscaping, **Yards of the Month**, appear in the May Bugler. Therefore, it is time to concentrate on our yards! (See Yard Criteria in this April Bugler.)

Thank you, Nino, for volunteering to plant flax lilies and revamp the drip system on the Hammerly/Wirt esplanade. We appreciate your continuing to help OSB with its landscaping in your old neighborhood.

Thank you, Bill Cox/LMC for maintaining all the esplanades on Hammerly. You are appreciated.

BEAUTIFICATION

The elements that make a neighborhood attractive and/or beautiful are 1) being in compliance with the Deed Restrictions, 2) following the City of Houston Ordinances (Codes), 3) following the Heavy Trash schedule, 4) keeping your property clear of junk and litter, 5) mowing/edging/weed eating your lawn.

For example, deed restrictions keep your neighbor from having a toilet business in their front yard, farm animals, parking a bulldozer in the driveway, etc.

- City of Houston Codes: can prevent storing junk cars, etc. in sight from street.
- Heavy Trash: keeps the streets clear of junk/tree limbs except for week of collection.
- Clear Property: keeps appliances, junk, indoor furniture off porches, litter all over yard.
- Mowing/Edging/Etc.: keeps your yard from looking like a cow pasture.
- City of Houston Ordinances

Violations like these listed above cause OSB's property values to go down.

What would you look for when shopping for a home? What must one do to sell a home?

- **Glass:** Bottles, jugs and jars only (emptied and rinsed)
- **Paper:** Newspaper, magazines, catalogs, junk mail, office paper
- **Cardboard:** Cardboard and cereal boxes (emptied of packing materials and flattened)
- **Plastic:** Bottles, tubs and jugs #1 - 5 and 7. Examples include water and soda bottles, milk jugs, yogurt cups, margarine tubs, detergent bottles, shampoo bottles. (emptied and rinsed)

SBISD BOARD OF TRUSTEES ELECTION ON MAY 4

The election for two positions on the Spring Branch ISD Board of Trustees is scheduled for Saturday, May 4, 2024. Candidates running for **Trustee Position 3**, listed in the order in which they will appear on the ballot are David Slattery, Ronald Hanson, Ben Drews and Matthew Cone. Slattery lists his occupation as architect, Hanson lists his occupation as educator SBISD, Drews lists his occupation as CSM, and Cone lists his occupation as manager. Running for **Trustee Position 4** is incumbent Christopher Earnest, who is running unopposed. Earnest lists his occupation as consultant.

Trustee positions are for three-year terms. All registered voters who reside in SBISD are eligible to cast ballots in the SBISD Board of Trustees election.

Early voting will be held April 22-30, Monday - Friday: 7 a.m. to 7 p.m. and Saturday: 8 a.m. – Noon.
If voting by mail, applications for ballots by mail must be received no later than 5 p.m. on April 23.

DEED RESTRICTIONS

Committee of Five

Just in case you are wondering, yes, some subdivisions in Old Spring Branch have Deed Restrictions. In these areas, that are deed restricted, they ARE enforceable.

Deed Restrictions are a written set of agreements/laws between you and your neighborhood. As such, it is usually up to you and your Civic Association to remind you and enforce them. However, the City of Houston Legal Department does enforce certain restrictions such as:








- 1) Affect the use to which a commercial or residential property may be used.
- 2) Fix the distance that structures must be set back from property lot lines and street lines.
- 3) Affect the lot size, re-plating & number of structures that may be built on the lot.
- 4) Regulate orientation of a structure, OR
- 5) Regulate certain fences types, heights and/or restricting fences on some lot areas

To file a complaint, call the City of Houston Deed Restriction Hotline at **(832) 393 –6333**.
