## **CITIZENS ON PATROL – NOVEMBER 2024**

Happy Thanksgiving! We reported **28.5 patrol hours for August, 27.25 hours for September and 31.75 hours for October.**

Lots of **Halloween decorations** are up in the neighborhood but I am sure they will soon be replaced with Christmas ones. It is hard to believe that Thanksgiving and Christmas are right around the corner. I am hoping that at some point in time, our weather will improve to more seasonal temperatures and rainfall.

We still have lots of activity around with **new construction**, house repairs from our summer storms and pick up of storm debris (which should be almost completed).

Reviewing our **incident reports**, I noticed an increase in Theft from Motor Vehicle incidents from previous months; please remember if you can't remove your 'valuables' from your vehicle, make sure they are out of sight and our vehicle is locked. Keep in mind that these incidents are crimes of opportunity, and we usually see an uptick with the Christmas holidays. We also see an increase in "porch thefts" during the holidays. Please plan your deliveries accordingly by using pick up locations or have packages delivered to your work location. The incident report does not give the exact location of the incident, but it does give us the general area of the incidents. The top two incidents' locations are 7400 Block of Long Point and 2000 Block of Antoine.

I have not heard of any plans for **Treasure Forest Elementary** yet. I am sure that SBISD police depart has cameras, alarms and other devices and are keeping it monitored for any unwanted activity. Our individuals hanging out close to Connie's Seafood have been disbursed on several occasions, but they manage to reappear a few days later to hang out. But their numbers have been greatly reduced and I am hoping at some point they find a home or move to another location.

We have had a couple of our **Citizens on Patrol signs** disappear and a couple that have been 'accidentally' knocked down. If you see one of our CP signs, please contact me so we can collect them. Please leave a message or send me a text.

Thanks to all our **CP volunteers**, I do believe we make a difference. We are always looking for volunteers, if you are interested, please contact me at 832-748-8088 and leave a message. We would love to hear from you! As always, be aware of your surroundings! Stay alert, be diligent and report any incidents that you see or hear. If the Police Department is not aware of anything going on in our neighborhood, they will not patrol our area. You can call the non-emergency number at 713-884-3131. If it is a life-threatening situation, please call 911!


As of Oct. 28, we still have 49 members.

## BEAUTIFICATION – HEAVY TRASH COLLECTION

Well, here we go again, the Junk Heavy Trash that was supposed to be collected the 4<sup>th</sup> Thursday of the month, October 24, was not collected. I reported it to Amy Peck's office on October 31. Solid Waste Department said that they are running approximately two (2) weeks late (behind).

The announcement from Solid Waste means that it will be Tree Heavy Trash month before the Junk Heavy Trash gets collected from Junk Month. **My suggestions is to separate your tree waste from your junk waste, curbside, until all Heavy Trash is collected. DO NOT MIX.**

Always call 3-1-1 to report YOUR uncollected, Garbage, Recycle, and Heavy Trash. Put Garbage and Recycle bins curbside after 6 p.m. the night before collection. Remove bins by 6 p.m. same day as collection. Heavy Trash can be put curbside seven (7) days before collection. Always give Solid Waste at least one (1) day extra for collections. After that, report failed collections to 3-1-1.

A reminder to all OSB residents, you are responsible for keeping your property free of code violations, complying with your subdivision's deed restrictions, mowing ditches, and clearing litter and junk from sight of street. This is your part of beautifying the neighborhood. 😊

**Metal and Cans:** Aluminum and Tin Cans. Examples include soup cans, vegetable cans, fruit cans, coffee cans (emptied and rinsed)

**Cartons:** Both gable top and shelf-stable food and beverage cartons. Examples include milk cartons, juice cartons, soup cartons, soy milk/alternative milk cartons (emptied and rinsed)

**Glass:** Bottles, jugs and jars only (emptied and rinsed)

**Paper:** Newspaper, magazines, catalogs, junk mail, office paper

**Cardboard:** Cardboard and cereal boxes (emptied of packing materials and flattened)

**Plastic:** Bottles, tubs and jugs #1 - 5 and 7. Examples include water and soda bottles, milk jugs, yogurt cups, margarine tubs, detergent bottles, shampoo bottles. (emptied and rinsed)

### **NO! Do NOT put these in your GREEN RECYCLING bin:**

Batteries/Electronics

Shredded Paper

Tanglers (cords, hoses, wires, clothing)

Food/Liquids; Trash and Bagged Recycling

Furniture and Household Goods
